

Why Cost Estimators Make the Best Expert Witnesses (Your next Career?) by Guest Speaker Steve Murow of Murow CM

Steve Murow, his construction career has spanned 40 years and during that time he has had many accomplishments. He started with a local grading contractor as an estimator, became a partner in a grading company, has worked as a consultant and then 6 years ago started his own company Murow CM. They specialize in land management and development and have performed litigation support, construction management, bid package preparation and review, dry utility coordination, etc. The company has grown from Steve originally to 62 employees currently and has been ranked for the last 3 years as one of Orange County's Best Places to Work.

Steve spoke about what is an expert witness? It is a person who is an "expert" or "creditable witness" with the necessary experience, education, special knowledge, certifications, membership in trade or specialty associations, etc. which illustrates a passion and desire for continued learning in his profession. Steve's experience includes having either bid or supervised over 2,500 estimates. "Estimators make good expert witnesses as they are good with numbers and understand their trade specialty". Attorneys know that the numbers have to be understood, accurate and



presented in an understandable manor so as to win the case.

His passion for being an expert witness is highlighted by the volunteering he has done which includes being past National President of the Forensic Expert Witness Association, past President of the FEWA-OC chapter and past President of our ASPE Orange County Chapter 3.

Steve said "you are an expert when you have had fun and done something for 40 years". We want to thank Steve for his presentation on being an "Expert Witness" and letting us know the future opportunity we have.
